Reminder! Revised CCP rules go into effect this year.

The revised rules went into effect at the end of February. The rules are posted to the Ohio Department of Higher Education's College Credit Plus website. Notable changes include, but are not limited to: summer term; eligibility and funding; new timeline for information sessions and monitoring the 30-hour limit.

YSU CCP application timeline has changed for 2017-2018!

If you provided feedback on our proposed timeline change, THANK YOU! After much discussion, we are changing the timeline in order to provide a final student roster by the middle of June. A breakdown of the old versus the new timeline is below.
