When reviewing this request, information from the Housing & Residence Life staff, as well as the information provided on this application, will be taken into consideration.

#### **Instructions:**

- 1. Complete this application and present the reasons for your request in an orderly, logical fashion. Provide specific information and make sure you have signed and dated the form or it will not be reviewed.
- Clearly indicate whether or not you will remain in classes at YSU. This is important in the review process.
   Registration will be checked.
- 3. Any request related to or for a medical reason should be accompanied by supporting documentation on official letterhead by a licensed practitioner. Medical reasons must relate to living on campus.
- 4. Any request related to financial concerns should be accompanied by relevant supporting documentation (i.e. unemployment notice) and will require the review of your financial aid information.
- 5. Any request claiming you did not understand the contract was binding will not be considered.
- 6. Only cases of demonstrated hardship that have occurred since the signing of the housing contract will be considered.
- 7. You should consider any application as "denied" until you are notified it has been approved. Please consult the housing contract for details regarding housing charges. https://ysu.edu/housing-and-residence-life/rates-and-contracts
- 8. Please note that release is NOT guaranteed and you are not approved for release from your contract unless you receive official written notification from the Office of Housing & Residence Life (this may be in the form of electronic correspondence.) It is strongly recommended you do not make alternative housing arrangements until you have received written notification that you have been released.

Cancellation before the end of Week 2 of the semester: 60% Refund of Room & Board Fees
Cancellation before the end of Week 3 of the semester: 40% Refund of Room & Board Fees
Cancellation before the end of Week 4 of the semester: 20% Refund of Room & Board Fees
Cancellation after Week 5 of the semester: 0% Refund of Room & Board Fees
